# **MEETING MINUTES**

#### Item 1: Welcome, agenda and minutes from meeting 3 - Rebecca Spencer

#### Item 3: Discuss the status and process of the Interim Report – Rebecca Spencer

# Main points discussed:

- The Interim Report was submitted to the Working Group and the Minister's Office for comments, most of which were included in the updated version of the report.
- Any outstanding comments / issues would be discussed and finalised during tonight's meeting.
- The final recommendation report will then be developed and provided to the Minister.
- The IWC representative informed the Working Group that Council has formally resolved the following:
  - "Request of the Government that a Master Plan and Plan of Management be developed for the Rozelle Parklands, as would be required for any new public park being established under Council's care, control and management. That the development of the Master Plan and disclosure of costings for the construction and ongoing maintenance of the Rozelle Parklands is a prerequisite for consideration the Government's request for Council to take on care, control and management of the Rozelle Parklands." (Source - IWC)
- Further discussions will take place between IWC and TfNSW regarding the CCM.
- The recommendations report will be finalised without references to the CCM.

#### Item 4: Discuss outstanding items - James Naylor

#### Main points discussed:

- The Working Group agreed that in the passive recreation recommendation section of the report it should be clear that passive recreation would be encouraged on the oval when not being used for organised sport.
- Cricket pitch the Working Group discussed the option of a synthetic cricket pitch in the centre of the oval and noted that it would unlikely disrupt passive recreation.
- The Working Group discussed the option of a fence around the oval, and it was noted that a fence may inhibit the openness of the parkland.
- It was raised that the turf on the oval should be of high quality to ensure durability.
- Amenities block the IWC Public Toilet Strategy recommends toilets be accessible within a 400 metre distance. The current location of the amenities block in the Parklands complies with the strategy.
- It was explained that if the amenities block were to be relocated to over to near the BBQ area it would be a very expensive exercise and might not provide significant benefit over and above the original proposed location.
- An alternative positioning of the facilities building semi-submerged into the embankment section near the oval remained an option, however, it would incur additional construction costs.
