Rozelle Interchange Wetlands Update





The WCX Civil maintenance team have increased their inspections of the Parklands area following the recent severe weather and rain events.

Wetlands Fencing Update WCX has now acquired an approved design for permanent fencing around the Wetlands. WCX has shared this proposal with TfNSW.

TfNSW is now in discussion with the supplier for next steps.







Rozelle Interchange – Rozelle Parklands Maintenance Update

#### Ventilation Outlet Façade Update

- Scoping proposal for trial with support from TfNSW's UDLP lead
- Plants to begin establishing themselves in a nursery in coming weeks
- Trial to commence around September 2025 (Spring) The established plant modules will be reinstalled on the outlets and monitored for a period of up to 6 months over Spring and Summer
- Results will be shared with TfNSW as the trial progresses.





The Parklands irrigation system has received an upgrade to better control the water for the area following observations by the WCX maintenance team.

Rozelle Interchange – Broader Updates



WCX has been working with TfNSW and the WHT D&C Contractor to complete lane adjustments within the Rozelle Interchange allowing for construction vehicles to use the live tunnel directly which will significantly reduce the number of trucks each day on the surface roads above (est. 1000 per day to use tunnel instead)



Vibration sensors have been removed by TfNSW following monitoring period post Opening.
