2. Explanation of Exceedances

18/10/2022: Monthly WTP samples were taken on the 18/10/2022. Results were received on 25/10/2022 and returned elevated ammonia and Chromium (VI) results in excess of the EPL criteria. The Operational WTP is currently undertaking its Pollution Reduction Program (PRP).

17/11/2022: Monthly WTP samples were taken on the 17/11/2022. Results were received on 25/11/2022 and returned elevated Chromium (VI) results in excess of the EPL criteria. It is of note that the Total Chromium for both samples on 18/10/22 and 17/11/22 returned a result below 0.0044mg/L with these anomalies being investigated with the sampling laboratory. The Operational WTP is currently undertaking its Pollution Reduction Program (PRP).
